Catawiki uses Cookies on its website, on its advertising services and on its mobile apps. Therefore we feel it is important to explain to you what Cookies are, which Cookies are used by Catawiki and why it is done. This Cookie Statement and your permission apply to all uses of the website and the Service. Please read the following information thoroughly so you understand how Catawiki uses Cookies and what your options are.

With regard to the personal data that is collected, we always handle it in accordance with the Catawiki [Privacy Policy](#). All capitalised terms are defined in the [Terms and Conditions](#).

A. What are Cookies?

Cookies use several techniques to post data on or to read data from devices of users, such as from your computer, laptop, tablet or smartphone. The best-known Cookies are small (text) files that are placed on devices and can be identified again at a later point. Other types of Cookies are javascripts, web beacons (tags) or device-fingerprinting. At the end of this Cookie Statement, you can find a list of all the Cookies that Catawiki uses.

B. How long do Catawiki's Cookies remain active?

The Cookies that we use vary in life spans. See the table at the end of this Cookie Statement for the specific retention periods. You can delete all Cookies from your browser whenever you want via the Cookie settings in your browser. The whereabouts of these settings differ depending on the browser that you are using. To find out where yours are, use the search function on the settings page or use the help function in your browser.

C. Do I have to give permission for the placement of Cookies?

Catawiki needs your permission for the placement of certain Cookies. The only Cookies that Catawiki can place without your permission are the Strictly Necessary Cookies. See the specific information below. When you visit Catawiki's website for the first time, you will see a notification which informs you about Cookies and asks for your consent (the Cookie Notification). By continuing to browse the website, after the Cookie Notification has appeared, you consent to the use of Cookies.

D. Can I revoke my permission?

In your Cookie settings, you can indicate that you no longer wish to receive Cookies. This does not apply to the Strictly Necessary Cookies. You can retrieve Catawiki's Cookies in your browser settings. Here you can also indicate which Cookies you wish to accept and which you wish to refuse. To manage Cookies from third parties you can visit the websites <http://www.networkadvertising.org/> or <http://www.youronlinechoices.com/>. These websites enable you to block Cookies from specific third parties.

E. What are the consequences of refusing Cookies?

If you refuse certain Cookies, certain features on Catawiki's Online Platform will not work.

F. Is my data transferred outside the EEA?

Some of the third parties concerned have offices in the United States or elsewhere outside the European Economic Area. They can transfer the data they collect with their Cookies to such foreign offices. If you give your consent to the Cookies concerned, this is regarded as consenting to any such transfer.

G. May this Cookie Statement be amended?

Catawiki may amend or supplement this Cookie Statement. The most up-to-date Cookie Statement can be found on the Online Platform or it will be brought to your attention when you visit the Online Platform. Catawiki strives to keep its Cookie information up-to-date but emphasises that Cookie overviews are always mere snapshots. Due to the constant innovation of the Online Platform, and the fact that the Internet and the various parties concerned are continually changing, it is possible that up-to-date Cookies and Cookie information are not always available in this Cookie Statement.

I. Which Cookies does Catawiki use?

Below we explain which types of Cookies are used, why we use them and for which purposes. In the table at the end of this Cookie Statement, you can see which specific Cookies Catawiki uses.

Catawiki uses so-called First Party Cookies as well as Third Party Cookies. First Party Cookies are placed and read by Catawiki itself. Third Party Cookies are Cookies that are placed and/or read by third parties.

Catawiki also uses so-called Tracking Cookies. Our own First Party Tracking Cookies are solely used to track the browsing habits on our own Online Platform. Third Party Tracking Cookies can also be used to track your browsing habits across multiple (other) websites, not only on our Online Platform. We cannot control such tracking and therefore would like to refer you to the privacy policy of the third parties involved. In the table at the end of this Cookie Statement you can see exactly which third parties place Third Party Cookies on Catawiki.

1. Functional Cookies

Functional Cookies are Cookies that are necessary, in order to make the use of the Online Platform or certain features possible. There is, for instance, a Cookie that makes sure you stay logged in, and do not have to continuously login when you click on a link on the Online Platform. Catawiki does not need your permission for the placement of Strictly Necessary Cookies. These are placed independently of consent when you visit the Online Platform or use relevant features. Catawiki uses the following categories of Functional Cookies:

1.1	Checks what type of account the user has.
1.2	Detects if the user is logged-in.
1.3	Stores the type of device that was used to visit the Catawiki website.

1.4	Stores the username for communication purposes.
1.5	Detects if the Cookie Policy was accepted.
1.6	Checks whether the gallery view or the list view is used.
1.7	Checks if the user is on the auction homepage or the Collectors' portal.
1.8	Stores the ID of the auction the user chose to see closed lots.

2. Analytic Cookies

Analytic Cookies capture how visitors use the Online Platform. Catawiki can use this information to analyse the use of the Online Platform, generate web statistics and determine what causes errors on the Online Platform. We use this information for analysis of the target audience and the market, for the improvement of navigation on the Online Platform and for resolving errors.

2.1	Tracks the number of users on the Catawiki websites.
2.2	Tracks the time each user spends on Catawiki web pages.
2.3	Tracks the order in which a user views different web pages.
2.4	Decides which parts of the Catawiki websites need to be improved.
2.5	Optimises the websites.
2.6	Shows feedback surveys to users.
2.7	Helps identify users by age, gender and interests.

3. Marketing

Some Cookies are used to show you relevant advertisements and to prevent you from seeing the same advertisements all the time:

3.1	Tracks which ads the user has already seen and prevents users from seeing the same ads all the time.
3.2	Tracks how many users clicked on an ad in order for Catawiki to settle payment with the company that the ad space was bought from.
3.3	Tracks what account type was registered after clicking on an ad in order for Catawiki to settle payment with the company that the ad space was bought from.

4. Interests

Catawiki uses Cookies to analyse and track your behaviour and interests. Based on this, we can show you advertisements and content that matches your interests the most.

4.1	Tracks user behaviour to get an idea about interests.
4.2	Checks whether an ad was clicked on.
4.3	Passes data about user behaviour to other websites.
4.4	Allows third party services to show ads to users.
4.5	Shows more relevant and interesting ads based on social media usage.

5. Social media

Catawiki wants to offer its users the opportunity to share their experiences with the Online Platform Website and Service via social media. For this reason, we have placed a few social media buttons and options on the Online Platform. Through these buttons and options, the respective social media providers can place Cookies, that they can subsequently read (Third Party Cookies).

5.1	Allows logged-in users of selected social media platforms to share content directly from the Catawiki websites.
5.2	Allows users to view embedded videos from our official YouTube channel using YouTube's privacy-enhanced mode.
